Official Rules

- Contestants must be 16 years or older
- Contestants may not touch the hot dogs until the starting signal
- All Hot Dogs include the bun, wiener and Texas Hot sauce. They may not be eaten separately. Only entire hot dogs eaten will be counted.
- Contestants will have 7 minutes to down all the hot dogs they can handle
 - Contestants will be provided water during contest for drinking
- When the 7 minute time limit is up contestants may not put any additional hot dogs or buns in their mouths. They will then have 30 seconds to swallow what is in their mouths. Any contents left in contestant's mouths at the end of the 30 seconds will not be counted
 - Partially eaten hot dogs will not be counted except in the case of a tie
 - Visible signs of sickness or vomiting will result in disqualification
 - First, Second and Third place winners will win cash prizes

I know that quickly eating large amounts of hot dogs is a potentially hazardous activity. I should not enter and eat unless I am in good health and medically able. I will not enter the contest if I have any food allergies to eating hot dogs. I will consult with my Physician before entering the contest. I authorize the use of any pictures or videos taken of me during the event to be used for publicity or any other purposes of Texas Hot Lunch. I realize that this is in good fun and I agree to be a good sport. I will abide by any decision of the contest officials and contest rules.
